### Eligibility Criteria include:

- Complete and submit the application in full at least 2 weeks before the start of a module. For Modules 2-6 applications will only be accepted from students who are enrolling for the first time in the academic year. Please see the website for specific deadlines.
- Provide a letter from AWANA headquarters certifying your receipt of the Citation Award.
- Completion of the FAFSA.
- Good Financial Standing at SCS. Should standing change, the recipient will become ineligible.
- Good Academic Standing at SCS. Should standing change, the recipient will become ineligible.
- Maintain on-campus enrollment if located within San Diego (El Cajon campus) or Los Angeles (LA site) county.

\* For Modules 2-6 applications will only be accepted from students who are enrolling for the first time in the academic year. Please see the website for specific deadlines.

SCS Institutional Policy is as follows:

- Scholarships are awarded as funds remain available. As funds are limited, scholarships are awarded on a first come, first served basis.
- Applicants must meet all eligibility criteria and provide all application requirements. This does not guarantee awarding.
- Applicants are eligible for only one Institutional scholarship per academic year. Funds will be applied after all other forms of aid have been deducted and may not produce a credit balance.
- Recipients must report any changes that occur in eligibility status. Failure to report changes is a violation of the Student Code of Conduct and scholarship funds may be revoked.
- Funds will not be applied to audit courses or courses taken for personal enrichment.
- Scholarship funds may not be used to pay any overdue past balances.
- Cal Grant recipients are not eligible to receive Institutional Scholarships.
- Recipients must re-apply each Academic year. Continuance of a scholarship is not guaranteed.
- Fees are not covered by Institutional Scholarships.
- Any failure of a course due to an earned grade of "F" or due to absences is not eligible for scholarship funds. Full cost of tuition and fees is the responsibility of the student upon failure of a course.
